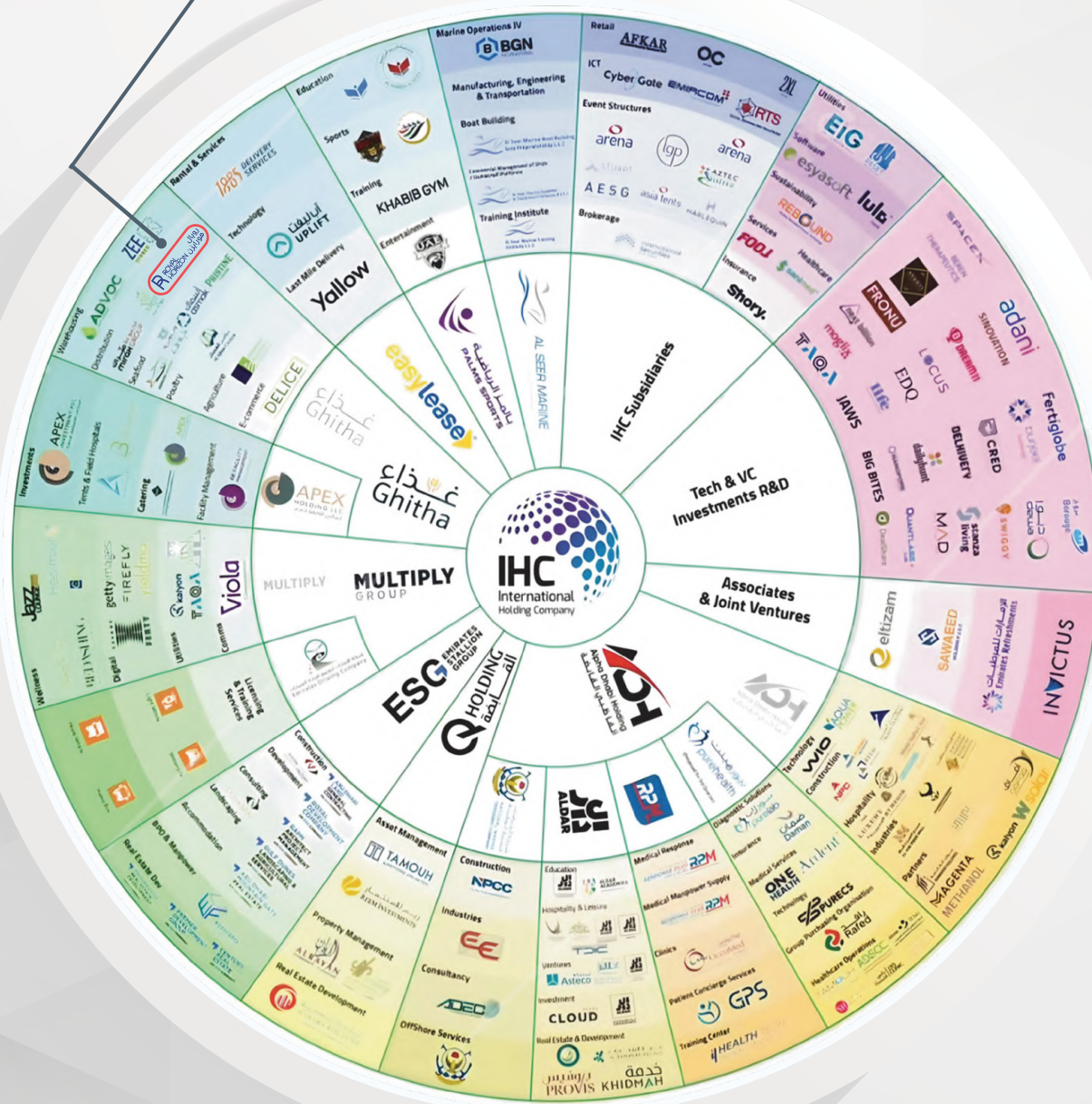

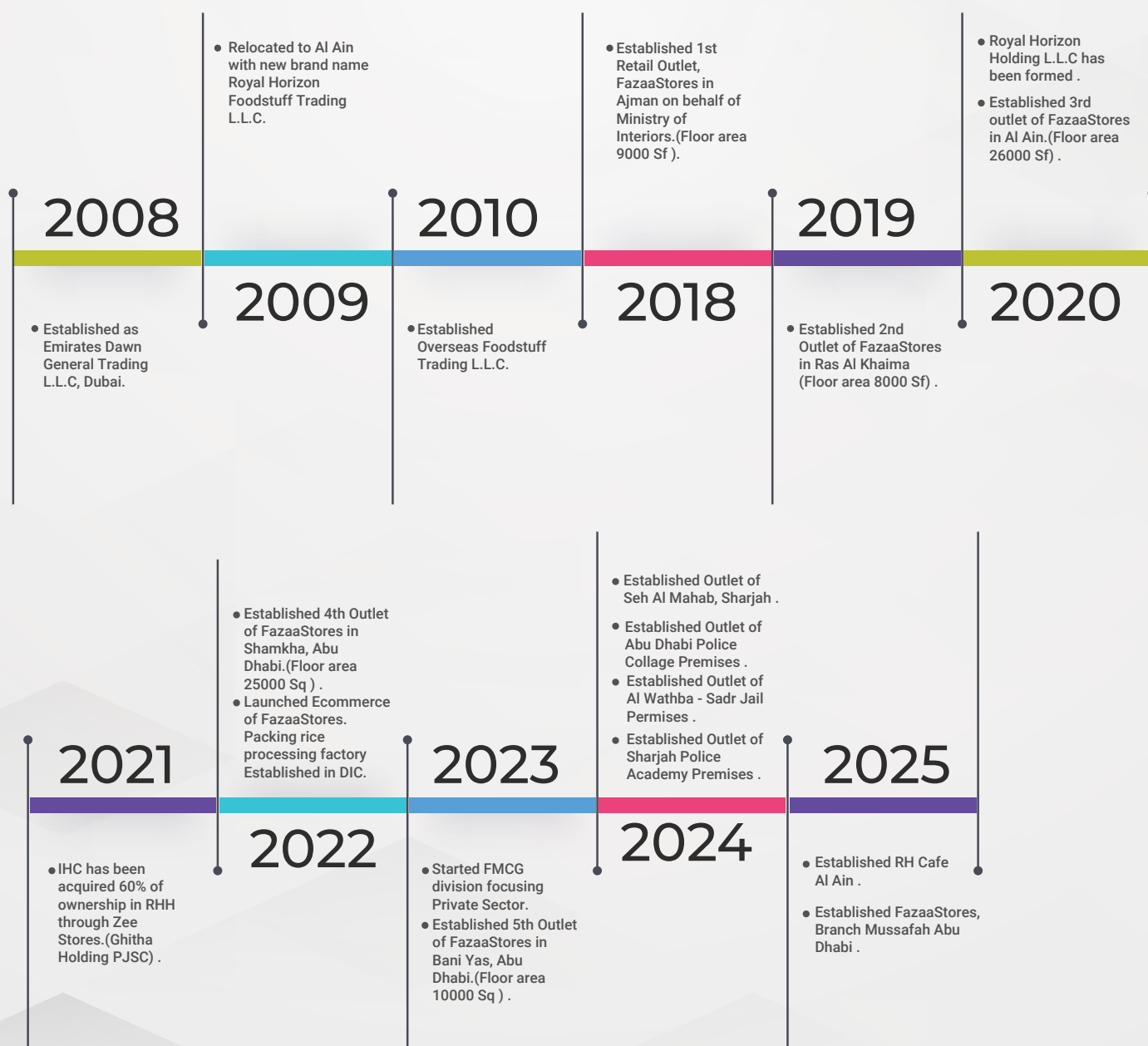
Who We Are?

Vehicles are **equipped with freezer, chiller, and ambient compartments**, enabling us to maintain the highest standards of quality and safety for all product categories – from frozen goods to dry commodities.

Our Storage & Processing – Scalable, Secure, and Strategically Equipped

Royal Horizon Holding operates over **170,000 CBM** of modern storage facilities, including **13,000 CBM of temperature-controlled cold storage**, ensuring optimal preservation and handling of diverse FMCG products.

We also operate a **dedicated rice packing unit** with a **daily capacity of 270 metric tons**, enabling large-scale processing, packaging, and timely distribution of high-quality rice varieties across our network.

To support future expansion, an **additional 44,000 CBM** of storage space **construction**, project is in pipeline.


